

EU's development policy and funding – changes for 2021-2027

- Focus in Africa and deepening cooperation
 - New international competition, migration, huge needs
- Traditional development assistance is not enough
 - Leveraging private funding (blending, guarantees)
- Need for consolidation of EU activities (multiple instruments, overlapping activities, low EU visibility)
 - <u>Team Europe Initiatives</u> joint design, financing and <u>implementation of actions</u> among EU, MS and their organizations
 - Single funding instrument <u>NDICI</u> or Global Europe

EU funding for developing countries – Pillars and geographic allocations



Per principal priority








EU Programming and budget execution phases
